## **CONGRESSIONAL RECORD ON REPRODUCTIVE FREEDOM 118<sup>TH</sup> CONGRESS, 1<sup>ST</sup> SESSION**

Reproductive Freedom for All’s (formerly NARAL Pro-Choice America) 2023 Congressional Record on Reproductive Freedom documents the key House and Senate votes taken on this issue during the first session of the 118th Congress.

For over 50 years, our organization and members have unapologetically helped lead the charge on both the state and national levels to protect and advance reproductive freedom through grassroots organizing, electoral change, and political advocacy. As we embark upon the next chapter of our fight in a post-*Dobbs* America, we have changed our name from NARAL Pro-Choice America to Reproductive Freedom for All. Our new name makes clear who we are, what our values are, and what our mission is: reproductive freedom for all.

### **Republicans in Disarray**

The 118th Congress began with Republicans in the U.S. House of Representatives in disarray. It took Kevin McCarthy (R-CA) 15 rounds of votes before he could lock in the necessary support to secure the speaker’s gavel—which he only held for nine months before he was ousted by his own party. Following weeks of uncertainty during which the GOP majority cycled through numerous nominees to lead the caucus, they elected extremist Mike Johnson (R-LA) as speaker. Johnson has an extensive record as an anti-abortion zealot—he has received a 0% score from Reproductive Freedom for All every year since he was elected to the House and supports a national abortion ban.

In fact, the one topic House Republicans could agree on during the first session of the 118th Congress was attacking abortion: two of the first votes McCarthy held when he finally became speaker in January were on anti-abortion legislation. This theme continued throughout the year. GOP spending bills contained new provisions that sought to further erode reproductive freedom, including language to roll back the Food and Drug Administration’s (FDA) January 2023 decision to remove restrictions that were not grounded in science and improve access to mifepristone, one of two medications used in medication abortion. And in an unprecedented move during the summer, House Republicans hijacked

a traditionally bipartisan bill—the National Defense Authorization Act (NDAA)—to push their anti-abortion, racist, sexist, and anti-LGBTQIA+ agenda at the expense of national security.

Senate Republicans took a similarly extreme approach. For 11 months, Sen. Tommy Tuberville (R-AL) single-handedly blocked Senate approval of more than 400 military promotions as a means to protest the Department of Defense’s abortion leave policy. Additionally, Republicans in the chamber forced a vote on a resolution that aims to overturn a Department of Veterans Affairs (VA) interim final rule that protects the reproductive freedom of veterans and their families.

### **House and Senate Democrats United for Reproductive Freedom**

In sharp contrast, we continued to see bold leadership from House and Senate Democrats in their efforts to restore abortion rights and protect reproductive freedom. For the first time ever, Leader Hakeem Jeffries (D-NY) marked the Women’s Health Protection Act (WHPA) among Democrats’ top 10 priority pieces of legislation. House Democrats also filed a discharge petition on WHPA in an attempt to force House Republicans to hold a vote on this critical legislation. The discharge petition was signed by every member of the House Democratic Caucus except lone anti-abortion Democrat Henry Cuellar (D-TX). House Democrats also remained united in their opposition to harmful anti-abortion riders in spending bills and the NDAA.

Champions in the Senate once again took to the floor to seek unanimous consent to pass several bills to protect reproductive freedom—including legislation on the right to contraception, the right to travel for abortion care, protections for providers, and protecting people’s online health and location data—yet, Senate Republicans prevented every single measure from being adopted. Senate Democrats succeeded at keeping the harmful and extreme provisions included in the House version of the NDAA from making it into the final version of the bill, and blocking Republican attempts to overturn a Department of Veterans Affairs (VA) rule that allows veterans, eligible family members, and caretakers to access abortion care through the VA in cases of rape, incest, and when the life or health of the pregnant person is endangered. Notably, the Senate confirmed three judicial nominees with a history of protecting reproductive freedom, including Julie Rikelman—the first reproductive rights litigator nominated

to the federal courts—who famously argued *Dobbs v. Jackson Women’s Health Organization* before the U.S. Supreme Court.

### **Abortion Back at the Supreme Court**

Beyond the halls of Congress, attacks on reproductive freedom played out in the courts. An ongoing lawsuit, *Alliance for Hippocratic Medicine v. the Food and Drug Administration (AHM v. FDA)*, challenges the legality of the FDA’s approval of mifepristone. Mifepristone is essential in the standard medication abortion regimen, as well as care for miscarriage management, and has been approved by the FDA for nearly two and a half decades. This case, in which the extremist Alliance Defending Freedom represents the plaintiff, was assigned to known abortion opponent and Trump-appointed Judge Matthew Kacsmaryk after being filed in a district where he is known to receive the vast majority of cases filed there. Kacsmaryk issued an injunction to rescind mifepristone approval while litigation continued, which was appealed by the FDA to the Fifth Circuit, where it was mostly upheld. The case was brought for review to the U.S. Supreme Court. On December 13, the Court issued an order to hear oral arguments in the case, which will likely take place in the spring of 2024. The Supreme Court’s decision to hear this case gives justices yet another opportunity to roll back abortion access in our country even further by placing extreme and medically unnecessary restrictions on mifepristone in all 50 states. As abortion access again hangs in the balance for millions of Americans, this case illustrates the power held by a single district court judge to shape reproductive freedom across the country. It is critical to put forward and confirm judicial nominees with records of protecting reproductive freedom to the federal bench.

### **The Biden-Harris Administration Seeks to Protect Abortion Rights**

The Biden-Harris administration continued to explore different avenues to protect and expand reproductive freedom through executive actions, including: the Department of Health and Human Services issuing a proposed rule to strengthen privacy protections surrounding reproductive health care; issuing guidance on and taking decisive action to enforce the Emergency Medical Treatment and Active Labor Act (EMTALA); signing an executive order to protect and expand access to contraception; and vehemently defending access to reproductive freedom through litigation, including to medication abortion by fighting against the *AHM*

*v. FDA* lawsuit. President Biden and Vice President Harris have been staunch champions on this issue and Reproductive Freedom for All was proud to endorse their run for a second term.

### **Democracy and the Fight for Reproductive Freedom**

This year illuminated the necessity of taking back the courts and protecting our democracy in the fight for reproductive freedom.

The post-*Dobbs* political landscape has shown the outsized impact of very few individuals on determining millions of Americans’ access to health care, bodily autonomy, and civil rights. As numerous reports of misconduct at the Supreme Court surfaced, Reproductive Freedom for All articulated support for strengthening ethics reform and called for Justice Thomas to resign. We will continue to hold our nation’s highest court accountable and in compliance with the highest standard of ethical behavior. Reproductive Freedom for All is proud to join progressive partners in calling for Supreme Court reform and expansion to uphold the legitimacy of our judiciary.

In 2023, the inextricable link between democracy and reproductive freedom was made even clearer. In August, extremist Republican lawmakers in Ohio attempted to diminish the power of voters through an anti-democratic ballot initiative. The ballot measure sought to raise the majority threshold for constitutional amendments in anticipation of a November vote on protecting access to abortion; Ohioans soundly rejected this proposal. When democratic mechanisms are safeguarded, the 8 in 10 Americans supporting the legal right to abortion make their voices heard.

### **Reproductive Freedom on the Ballot Wins, Again**

The outcomes of this year’s elections serve as a powerful indicator that abortion continues to matter to voters. Across the country and across party lines, voters took to the polls in support of reproductive freedom. Ohioans passed Issue 1, amending the state constitution to enshrine access to abortion. In Virginia—the final Southern state without an abortion ban—reproductive freedom voters turned out to win the state Senate and flip the House of Delegates, rejecting Governor Glenn Youngkin and his proposed 15-week abortion ban. Democratic Governor Andy Beshear won reelection in Kentucky, while Judge Daniel McCaffery defeated an anti-abortion Republican for a seat on the Pennsylvania Supreme Court. Reproductive Freedom for All is proud to have endorsed candidates dedicated to fighting for reproductive freedom.

## VOTE DESCRIPTIONS SENATE

- 1. Rescind VA Abortion Rule.** A resolution to express congressional disapproval of the interim final rule relating to abortion care, S.J.Res.10. Motion to proceed to consideration of the resolution. This measure would reverse the Biden administration's rule that allows access to abortion care through the Department of Veterans Affairs (VA) in certain cases and allows VA to provide comprehensive information on pregnancy options. Failed 48-51. A vote for reproductive freedom (+) was against the motion to proceed (4/19/23).
- 2. Equality Under the Constitution: Motion to End Debate.** A resolution to eliminate the deadline for ratification of the Equal Rights Amendment (ERA) to the U.S Constitution, S.J.Res.4. Motion to invoke cloture (end debate) on the motion to proceed to S.J.Res.4. Three fifths of the Senate (60 votes) is required to invoke cloture on legislation. Cloture motion failed 51-47. A vote for reproductive freedom (+) was in favor of cloture (4/27/23).
- 3. Garcia Nomination.** Vote to confirm Bradley Garcia, a nominee with a positive record on reproductive freedom, to the U.S. Court of Appeals for the District of Columbia Circuit. Confirmed 53-40. A vote for reproductive freedom (+) was in favor of confirmation (5/15/23).
- 4. Abudu Nomination.** Vote to confirm Nancy Abudu, a nominee with a positive record on reproductive freedom, to the U.S. Court of Appeals for the Eleventh Circuit. Confirmed 49-47. A vote for reproductive freedom (+) was in favor of confirmation (5/18/23).
- 5. Rikelman Nomination.** Vote to confirm Julie Rikelman, a nominee with a positive record on reproductive freedom, to the U.S. Court of Appeals for the First Circuit. Confirmed 51-43. A vote for reproductive freedom (+) was in favor of confirmation (6/20/23).

HOUSE

- 1. Interference in Abortion Practice.** Born-Alive Abortion Survivors Protection Act, H.R.26. Wagner (R-MO) bill to interfere with the medical practice of abortion care under the threat of severe penalties. Passed 220-210. A vote for reproductive freedom (+) was against passage (1/11/23).
- 2. Resolution on Fake Health Centers.** A resolution condemning violence against anti-abortion fake health centers and failing to recognize the real threats and attacks against reproductive health care providers and clinics, H.Con. Res.3. Passed 222-209. A vote for reproductive freedom (+) was against passage (1/11/23).
- 3. Attack on Servicemembers' Access to Abortion: Jackson Amendment.** National Defense Authorization Act for Fiscal Year 2024, H.R.2670. Jackson (R-TX) amendment to repeal the Department of Defense leave and travel policy that eases the burden of the statutory restrictions that force servicemembers and dependents to travel to access reproductive health care, including abortion services. Passed 221-213. A vote for reproductive freedom (+) was against the amendment (7/13/23).
- 4. Attack on Servicemembers' Access to Abortion: Final Passage.** National Defense Authorization Act for Fiscal Year 2024, H.R.2670. Final Passage. A bill to authorize funding for certain defense, military, and national security programs which repeals the Department of Defense leave and travel policy that eases the burden of the statutory restrictions that force servicemembers and dependents to travel to access reproductive health care, including abortion services. Passed 219-210. (Some lawmakers who oppose reproductive freedom cast what appear to be votes in support of reproductive freedom; most observers recognize that those votes were cast for reasons unrelated to reproductive health.) A vote for reproductive freedom (+) was against the bill (7/14/23).

Failed 161–270. A vote for reproductive freedom (+) was against the amendment (9/27/23).

Harshbarger (R-TN) amendment to eliminate funding for the White House Gender Policy Council which is charged with advancing gender equity and equality, including reproductive freedom. Failed 205–211. A vote for reproductive freedom (+) was against the amendment (9/27/23).
- 13. Prohibiting Funding for the Office of Population Affairs.** Labor, Health and Human Services, Education, and Related Agencies Appropriations Act, 2024, H.R.5894. Miller (R-IL) amendment to eliminate funding for the Office of Population Affairs which administers critical reproductive health programs. Failed 204–224. A vote for reproductive freedom (+) was against the amendment (11/15/23).
